Dear Bloom Trail Student and Parent:

Bloom Trail High School strives to provide a positive social atmosphere at scheduled dances that are held throughout the year. **To promote an appropriate environment for students, both dress code regulations and student behavior guidelines are enforced. In order to purchase dance tickets, students must agree to abide by the school dress code and behaviors listed below.**

BASIC SCHOOL RULES

Students are expected to follow school rules as outlined in the Student Handbook.

DRESS CODE

Bloom Trail High school developed a dress code policy with standards that promote safety, cleanliness, and decency. Students who do not follow the dress code will not be allowed into the dance, will need to be picked up and **NO REFUNDS GIVEN**. This policy also applies to any guests. **Dress Code guidelines include, but are not limited to:**

- No revealing clothing may be worn No see-through clothing or cuts or gaps causing the clothing to be too revealing
- No denim, jeans, t-shirts, sweats or jogging suits
- No clothing or jewelry that is sexually explicit
- No apparel that exposes the posterior
- All school dress code rules apply at all school events

School administration reserves the right to make decisions on student dress based on appropriateness and good taste.

DANCE GUIDELINES

If you are suspended the Thursday before the dance or the Monday following the dance, you will not be allowed to attend the dance. Any inappropriate behaviors that go against school rules will result in removal from the dance **without a refund**. This includes failing to follow the dress code policy. Also, dancing that is inappropriate, overly sexual in nature, or deemed inappropriate based on district/community standards is not allowed. **Students that are placed on the "Social Privilege Freeze" will not be able to attend any school events, including prom. School officials reserve the right to make decisions on suitable dance movements and appropriate behaviors. If your student is under the influence they will be removed.**

YOU MUST ARRIVE TO THE DANCE BY 7:15 PM.
NO REFUNDS WILL BE MADE FOR REMOVAL FROM THE DANCE.

Once you leave Prom, you will have an allotted time to arrive at Odyssey Fun World. The doors will close at **12:15 a.m.**, you will **NOT** be allowed in after that time and a **phone call home** will be made if you checked yes to attending Post Prom. In addition, the goodnight rule is in effect, if you leave Post Prom you are **not** allowed back in. Once at Odyssey Fun World, you will be treated to 3 hours of full use of the facility, pizza and refreshments.

EACH student/guest attending Prom must bring this form, with a parent/guardian signature, to the bookstore when buying their Prom tickets.
